I would certainly appreciate it if the NAACP would give some attention to this matter. I am enclosing copies of letters which I wrote to the presidents of the Eastern and National Airlines concerning this practice. You will note that the Eastern Airlines gave a very sympathetic reply, while National seemingly did not recognize any moral responsibility whatever in the matter. I feel confident that you would be helping the race in the matter of air transportation in the figure by giving a thorough study to this refusal of service and take proper action. Perhaps the policies of the National Airlines would merit thorough consideration by your legal force. With your permission, I am sending copies of these communications to you for Mr. Thurgood Marshall in your New York office, as well as to Mr. Harry T Moore, executive secretary of the Florida branch of the NAACP.
