Dear Congressman Fuqua:

Because of the gravity of the implications of the "Quie Bill," I wish to register the concern of several of the citizens in this educational community.

We are of the opinion that the "Quie Bill" should be defeated. We appreciate the national concern that more of the Federal funds be allocated to the states for proration among agencies, public and private, within the state but from reading the reports to the House, the viewpoints of the Association for Higher Education and a discussion with representatives from twenty-seven colleges that met in Virginia last week, there is a general feeling that this bill should not be allowed to become law.

You have an admirable record during your tenure as our representative to Congress. We hope that you will study the intent of the bill carefully and use your influence to defeat the measure.

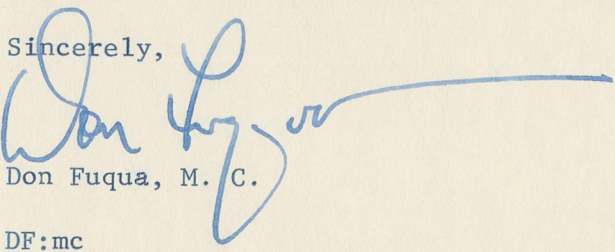
Dear Dr. Perry:
