"We must purge ourselves of

the paranoid fear that the public 'will find out' about us and see to it instead that the public does find out more about the first and most crucial of academic principles: The pursuit and protection of truth."

The McGehee's that fact statement tragically applies to FAMU has nothing to do with

the fact that almost all-Negro.

Other universities of all sizes — including all types and sizes — including FSU — have suffered from the

FSU — have suffered from the same malady.

But perhaps FAMU stands to lose more than the others.

FAMU is located in a ripe, growing state that has in it people with fresh, new ideas. There are many Floridians who would be interested in helping FAMU students get a better education — if they could only be made aware of FAMU's needs. FAMU's needs.

FAMU's main problem doesn't seem to be public hostility. It is public in-

difference.

Indifference to problems was never cured by pretending the problems didn't exist.

PERHAPS THE STUDEN at Florida's only Negro university will be so determined to get a better education ed to get a better education that they'll continue to work for it, with the help of progressive faculty and staff, inspite of adults (black and white) who fear change.

But signs at FAMU indicate

students may not be that pa-tient. Even if they were, ra-tional, mature students and their progressive grown-up helpers might not have enough backing to keep student majority support from forming behind radicals who promote violence and promise fast ac-

tion.

The young Alabama PR man had several good suggestions that can apply to creating public support for any university, "predominantly" any color at all:

Speaking of college PR men (and the administration that often stifles them), he said, "Our work is not raising walls or throwing up smoke screens.

or throwing up smoke screens around the academic world.

"Our work is building bridges of communication between the academic and public realms,"

AND HE SAID, "College relations officials can fall too easily into the trap of reporting life at the edges of the campus: fraternity and sorority teas, successful fund drives, visits by movie stars,

and student antics.

"In turn, the public concludes that this is what college

is all about — and that classes and libraries and research are

relatively unimportant."

During the past two weeks,
FAMU has had enough
generated enthusiasm to build a better university on any campus, but some officials have refused to let it get around.

The public may not have been very interested in it in the past, but FAMU is a public university.

And not wanting to tell the public about a school sure isn't any way to win public interest

or support.

Maybe the formula for raising public support for other colleges somehow doesn't apply to FAMU. Maybe the fact that FAMU is beingFlorida's onl y State-supported Negro university somehow enables it to play by different rules.

But I doubt it.

# Deans Hear Critic DEMOCRAT 24 Apr 68:17 Spread Power, FAMU Advised

Florida A & M University is handicapped because it has too much power in the hands of too few administrators, an administrator of another Negro college said Tuesday.

Ben Smith, of Morgan State College, was on the FAMU campus Monday, Tuesday and today as one member of a team from the Southeast regional accrediting agency.

The Southern Association of Colleges and Schools, which meets annually in the fall to grant or deny accreditation to schools and colleges, sent a 13-man team to A & M this week. on a regularly-scheduled visit.

Chairman of the study committee was Dr. John H. Allen, a dean from the University of

Southern Mississippi.

Smith, a well-known Negro educator and a member of the SACS team, called FAMU deans together Tuesday for an informal discussion.

Some of his criticisms, and some of his recommendations had already been brought out in faculty-student discussion following a flare-up of violence on campus April 4.

Smith reportedly told the deans A & M lacks "an atmosphere conducive to learn-

He said, in effect, that department heads and deans must be given more authority to upgrade programs and stimulate their faculty and students.

Smith criticized the fact that the university's faculty senate is not allowed to play a bigger part in suggesting curriculum improvements and improvements in university structure.

The university president, Dr. George Gore, should not main permanent chairman of faculty senate, Smith said, and the senate should elect new secretaries each year rather than having a permanent secretary who is an ad-ministrator, as it has in the

No man knows enough to run an institution of this size by himself, one dean quoted Smith as saying.

Although Smith's remarks to the deans Tuesday were completely informal and reportedly stimulated by his personal concern for FAMU, he will write a formal report later on his findings.

This week's visit by the SACS study team is not related to the violence that closed down FAMU classes for a week.

The study of FAMU, its administration and all its programs, is part of a regularly-scheduled study carried out periodically by the SACS.

Team members consulted with Gore as well department heads and other administrators during their visit.

Now, if that was only language to show firm intent, it may do little harm; but if the committee and those it is assumed to represent take it seriously as a guiding force.

It would mean Florida and M. University would be turned over to this particular group of students and faculty to be run as they please both teaching and discipline.

Student bodies and faculties must understand that they are in no position to "insist" that the administration "honor and implement" their recommendations - not at FAMU, FSU, or any other college, privately or publicly operated.

Students don't have any right even to attend a university, except as they accept policies and regulations of those duly constituted by law and charter to be in charge. No person has a real right to teach at a university, let alone participate in dictating terms to the people who employ him.

If the committee is directing ultimatum at President Gore, it should recognize that he is properly limited in how far he can go by decisions of the Board of Regents, Board of Education, Budget Commission. Florida Legislature - and the people of Florida who put up the money through taxation.

No records should be kept which reflect the political activities or beliefs of students.

"The student press," the statement said, "should be free of censorship and advance approval of copy, and its editors and managers should be free to develop their own editorial policies and news coverage."

The statement also supported the rights of students to freedom of speech, peaceful assembly and the right of petition.

In disciplinary situations, the statement says that students have the right to be fully informed about the nature of charges against them and that institutions must refrain from arbitrary actions. Support for the right of appeal by students also is included.

### Over-Stepping Can Trip Reform

Reform movements stumble and fail, mostly, from over-stepping; and that could happen to one now developing on the Florida A. and M. University campus.

A "Student-Faculty Committee on University
Improvement," rather loosely
and hastily organized during
the week's suspension of classes following rioting on the campus, has come up with a campus, has come up with a four-point resolution that is three-fourths good and one-

three-fourths good and one-fourth out of bounds.

As Terry Frost, Democrat Education Writer, reported Sunday, unrest on the campus may be due as much to un-certainty over the future role and administration of the university as over the broader social conflicts among Negroes of the nation.

of the nation.

Bluntly put, this institution which once was operated solely for and by Negroes (and still is, predominantly) is fretful about the threat of disintegration in the onrush of

desegregation.

The man on the spot is President George W. Gore, Jr., who has probably the toughest job in Florida because he must stand between and act for both his Negro students and faculty and an all-white series of boards and political bodies which control the flow of operating funds and policies.

There is a complaint on the campus that 'the administration' — apparently meaning President Gore — takes too little advice in running the university from the faculty and students. desegregation.

## **Professors Back Students**

WASHINGTON (AP) - The American Association of University Professors, an organization of 90,00 college and university teachers, gave overwhelming approval Friday to a new bill of rights for students including a recommendation that they participate in the "formulation and application of institutional policy."

More than 500 delegates to the association's 54th annual meeting endorsed a joint

statement on rights and freedoms of students drafted by the association, the U.S. National Student Association. the Association of American Colleges, the National Assoication of Student Personnel Administrators and the National Association of Women Deans and Counsellors.

Approval of the statement came as student power advocates disrupted activities on widespread American campuses in demonstrations to enforce student demands on university and college administrations.

The joint statement specifically states that students, as constituents of the academic community, should be free to express their views on issues of college and university institutional policy.

"The student body should have clearly defined means to participate in the formulation and application of institutional policy affecting academic and student affairs," the statement declared.

The statement said also that students should be allowed to invite anyone of their own choosing to address them on campus and that they should be free to organize and join associations to promote common interests.

The statement made these additional points:

Under no circumstances should any student be barred from admission to a particular institution on the basis of race.

Students should be free to take reasoned exception to views offered in any college course of study-but they are responsible for learning the content of any course of study for which they are enrolled.

# Bombing Blaze Is Fatal

### FAMU Campus Is Still Tense

By BRIAN HOWLAND Democrat Staff Writer

The Florida A&M University campus was quiet but tense today after violence erupted last night as an aftermath of the assassination of Dr. Martin Luther King.

About 2:30 a.m. today, a 19-year-old white youth was asphyxiated in his father's firebombed store, but police did not definitely connect the death with a university student or students.

The victim was Travis E. Crow III.

Coroner James Gwynn ruled the death homicide through

This morning, classes were held as usual, with some students attending. But many students gathered instead in the student union and on lawns to discuss last night's seven hours of violence on the campus.

At 10 a.m., students jammed into a campus auditorium for a memorial service to honor

93 bodies in the barbed wire around the night camp, and said Marine casualties were extremely light.

It was the heaviest fighting of the five-day-old operation to open Highway 9, the only overland supply route to Khe Sanh, and relieve the base. Most of the enemy dead were killed by dive bombers and artillery.

U.S. headquarters said no Marines were killed and only two wounded in the two-hour fight.

The hilltop battle pushed the total number of North Vietnamese reported killed in the five-day operation to 180. U.S. losses were put at 24 dead and 211 wounded.

One general in the U.S. command, while not saying specificially what shifts would be made at Khe Sanh, agreed it would be a good assumption that either one of two things could happen in the near future:

—As the enemy reduces his forces around the base, a withdrawal which U.S. officers believe has started, the Marines likely will do the same, from the 6,000 men now there, pehhaps down to 1,000;

—Or South Vietnamese or

Or South Vietnamese or U.S. Army troops may replace some of the Marine units. There are now 400 South Vietnamese rangers and another 00 civilian irregulars helping efend the fortress.

The officer said there are till North Vietnamese troops around Khe Sanh but "not in the force they were in a while back."

The average undergraduate at FAMU is 20 years old, and most of them entered the university with a high school test score below 200. I just do not believe they are ready to run the university, and if they are, I believe the university should close.

I believe the upheaval is guided by outside people and faculty members who are pushing to cover up their weaknesses or trying to move up by pleasing students.

Recently, the newspaper reported that the new chancellor visited A&M's campus and talked with militant students. I would suggest a talk with all student groups. To just talk with militant students gives them status and they can make other students think they have established rapport that they can share with

While I hope all just demands will be met, I believe the real problem is bigger than what we see on the surface. I believe that there are some faculty members and some students the university will have to get rid of before the confusion terminates . . .

The I Declare column of April 16, 1968. demonstrates lack of perception of the world

of the Negro characteristic of so many whites. To imply that faculty and students "develop the same rapport . . . which exists at FSU. the University of Florida, and other state universities . . . is a benign insult to FAMU students and faculty and to Negroes in general. As one who has teaching experience at FAMU, FSU, the University of Florida, and has lectured at every other state university, I hardly feel that faculty-student rapport at other state universities is the appropriate paradigm for FAMU.

If I Declare were informed, it would be aware that the great bulk of student complaints at FAMU are not directed at the faculty. That students have been at odds with administrations at other universities is rather easily and vividly documented. Recently the University of South Florida had its problems with obscenity; Florida State University with narcotics; and the University of Florida with nudity: indicating the dubiousness of FAMU's emulation of them, in student-administration relations.

Duly constituted committees have the right to insist that their recommendations be implemented. There would be no point in making recommendations if commitments to support did not accompany them. Students have the right to insist on anything they like. Faculties have the right to insist on anything they like. Administrations have the right to insist on anything they like. Even editors have this right. If one wishes to interpret the word "insist" to mean "ultimatum" he has the right to do so even though it may indicate a personal problem with semantics.

Students and faculties are among "the people of Florida." Students pay taxes. Faculties pay taxes. By your own reasoning, therefore they have the right to be heard on university administrative matters.

He gained national stature by serving as chairman of both the Southern Governors' Conference and the National Governors Conference. And in 1960 he won nationwide commendation for his performance as chairman of the Democratic National Convention.

As Governor, Mr. Collins demonstrated constructive leadership, integrity and courage under fire.

He was a champion of better schools. During his administration teacher salaries were raised, the junior college system was greatly expanded and the first new state university outside Gainesville and Tallahassee was established — the University of South Florida.

Road funds, formerly divided among the districts on a Pork Chop basis with little regard to traffic needs, were apportioned more fairly. And a merit system for employes under the executive department was installed, to end the traditional "suitcase parade" accompanying every change in administrations.

BUT MR. COLLINS' finest service to this state was his skillful handling of the tense racial situation which followed the Supreme Court's school desegregation decision in 1954. He fought to keep the public school the

Mr. Collins in 1964 to direct the new Community Relations Service, established to work out voluntary solutions to racial problems. Mr. Collins, at that time head of the National Association of Broadcasters, left this \$75,000-a-year job to take the government post paying one third as much. He said he felt he could render greater public service in doing so. This explanation, which from many men in politics would have been rejected as hypocritical, seemed typically Collins.

The Community Relations Service did most of its work out of the spotlight. But on one notable occasion, a confrontation between Dr. Martin Luther King's marchers and a tough sheriff's army at Selma, Alabama, LeRoy Collins was physically on the front line working to avoid a clash which could have taken scores of lives. The crisis ended without bloodshed.

Mr. Collins subsequently served as Undersecretary of Commerce.

This background equips him with exceptional qualifications for the United States Senate. No man knows Florida, its government and its people better than he does. And because of his national stature and his Washington experience, he would command greater influence than the ordinary freshman Senator.

Mr. Faircloth's performance as Attorney General, we regret to say, has been disappointing. He has shown neither the leadership nor the dedication to duty that would commend him for higher office.

## Some Changes May Be Coming At A&M

By TERRY FROST Democrat Staff Writer

It's beginning to look as if a new atmosphere of growth might bring some changes to Florida A & M University.

FAMU President Dr. George Gore today has accepted most of the proposals for change presented to him by a facultystudent committee formed in the wake of campus violence three weeks ago today.

Students showed new enthusiasm when the greatest number of student voters in the school's history turned out for student government elec-

tions Tuesday.

Some of the faculty-student proposals were modified or combined by Gore and faculty members.

Three proposals—reportedly dealing with redistributing the powers of the university's dean of students - were rejected.

The recommendations ac-

cepted by Gore include:

\_ More student involvement and student say-so in activities directly concerned with students, such as homecoming, the student newspaper, and rules and discipline.

- More frequent publication

of the student newspaper.

 More students appointed to committees dealing with discipline and with recruiting new students.

— More privacy for students

in the health clinic.

- Regular meetings between students and their major professors or counsellors, who have spent relatively little

time with students in the past.

- Revamping the process for securing short-term student loans, and facilitating the registration process.

- Offering more Afro. American courses in the cur-

riculum.

- A more effective committee or mechanism for faculty evaluation.

Gore announced no time schedule for implementing the

changes.

The proposals came about through a series of meetings where faculty and students discussed problems and possible solutions.

One of the students' major grievances was the actions of the dean of student's office, which has final say on many student activities that are largely student-run on other campuses - student publication, for example.

The students also complained that favoritism was shown in handing

scholarships and loans.

The fact that 21 proposals have been accepted doesn't necessarily mean the end to changes, a university spokesman said today.

The faculty has elected eight members to an Improvement Committee that will hear complaints and make suggestions for more needed changes.

The committee will be composed of eight professors, already elected by the faculty, and eight students to be appointed by the Student Government Association.

# More Proposals DEMOCRAT 19 April 68: 9 Expected At A&M

A facultystudent committee has drawn up 24 proposals to present to Florida A & M University President Dr. George Gore, but the recommendations were labeled a "Progress Report," indicating more changes will be suggested to Gore in coming weeks.

A subcommittee put the preliminary 24 proposals into written form after a faculty-student meeting Wednesday night.

Contents of the proposals had still not been made public today, but sources indicated several dealt with redistributing the powers wielded by a FAMU dean.

The FAMU faculty started a reform movement when they met last week, while the campus was closed to students.

In an April 9 session, a 24-member f a c u l t y committee was appointed to draw up recommendations f o r improving FAMU's academic atmosphere and reducing student tensions.

Sunday afternoon, April 14, the faculty committee members were joined by about 120 students, invited by the committee to represent students' viewpoints.

April 15, in a night meeting on campus, the same faculty-student group, n u m b e r i n g about 150, had a talk session in which they listed additional recommendations.

Many of the changes suggested by both faculty and students were distilled and compressed into the 24 proposals drawn up for Gore Wednesday.

The FAMU president was expected to suggest some changes of his own in some of the proposals and to accept others.

Although some members of the university community — both faculty and students — have objected to making any of the committee's actions public, others have wanted open lines of communication to the press to encourage public understanding of FAMU.

By the end of Wednesday night's meeting, many professors and students were tired out from meetings held almost daily since students returned to campus Sunday. Partly for that reason, date and time for the next faculty-student meeting — to be aimed at forming further recommendations — hasn't yet been announced.

# FAMU Committee Passes Resolution

A resolution passed jointly by a faculty committee and about 100 Florida A & M University students S u n d a y says FAMU must continue to operate, uninterrupted by violence, "in an atmosphere of order with mutual trust... between students, faculty and administration."

Classes resumed today after being suspended for one week following violence the night Martin Luther King was shot.

According to the resolution passed Sunday, a special faculty committee and students will continue to meet every day until specific recommendations can be drawn up for righting some wrongs both students and faculty see at FAMU.

Some of the needed changes were discussed Sunday, but the nature of possible specific recommendations were not disclosed.

The Sunday resolution states that once reocmmendations are drawn up, the faculty-student committee "will insist that the administration honor and implement them."

In spite of the strong position indicated by that statement, final decisions on whether to put changes into effect will rest with university president Dr. George Gore and his administrative staff.

The faculty committee that met with students Sunday included chairman L. W. Neyland, several members appointed by Gore, and two faculty members who volunteered and were allowed to serve on the committee.

Gore reportedly jonied the Sunday faculty-student session for introductory remarks, then withdrew to let the discussion continue freely with no administrators present.

Tonight's meeting, reportedly open to administrators as well as faculty and students, was scheduled for 7 p.m. in the Embassy Room on campus.

Neyland said today the campus atmosphere seem ed normal. "There seems to be a considerable amount of school spirit," he said. Neyland added he had normal attendance in his classes this morning.

Wording of the studentfaculty resolution passed Sunday was as follows: "A. The university must continue to function.

"B. This functioning must place in an atmosphere of order with mutual trust and confidence between students, faculty and administration.

"C. The presently constituted faculty-student committee (representatives) will continue to meet every day until specific recommendations are drafted which we are assured will receive immediate attention by the administration.

"D. The faculty and student pledge total commitment to mutual recommendations adopted by this committee, and will insist that the administration honor and implement them."

More than seven weeks after some 24,000 of the state's 60,000 school teachers quit their classrooms Feb. 19, and a month after 15,000 of the 17,000 or so bitter-enders capitulated and agreed to return, there are still more than 500 of them not teaching.

The reasons vary, but generally it is because school boards insist they will rehire them on an individual basis only, and on annual contracts instead of with previously-earned tenure. The teachers vow the only penalty they will pay for their crusade for better education is loss of pay while they were out.

Some school boards undoubtedly seized the chance to reject those teachers suddenly swallowed hard and accepted what seemed to them harsh terms. The bitterness lingers, and perhaps affects classroom attitudes. Other teachers found their spots filled by qualified replacements, thus had no jobs to return to.

Gore and his administrative staff have planned another meeting for Monday, when students are due to return to campus. The meeting will possibly include faculty or students, or both. Plans will be firmed up later this week, Collington said.

Administrators were also expected to tell faculty members tonight the origin of last Friday night's decision to send students home from FAMU for one week.

The authorization for and announcement of the closing came from universities chancellor Robert Mautz.

However, Collington s a i d non-violent student leaders had themselves suggested the closing earlier Friday, and FAMU administrators had also felt it might be advisable.

Continuing education programs will be carried on throughout Florida as usual, and faculty members will work on campus this week. Students return to campus here April 15.

As faculty returned to their offices this morning, a picture emerged of meetings held Friday and Saturday aimed at containing and curtailing the violence that started Thursday night.

As the noise of student troublemakers carried into the home of FAMU president Dr. George Gore Friday night, Gore was in consultation by telephone with Board of Regents members and chancellor Robert Mautz.

Perhaps partly as a result of the discussions, Mautz announced on-campus classes were called off until April 15.

Un iversity administrators met several times Friday in an attempt to head off Friday night's violence.

Students called a meeting at 2 p.m. Friday, at which a faculty member and several student leaders argued with militants who were demanding violence.

Although the six youths arrested Friday night were not students, there was a hard-core handful of milit ant students who were vowing as late as 5 p.m. Friday to wreak violence on the FAMU area.

After the 2 p.m. meeting Friday, Gore and his Cabinet (administrators and deans) met with several students, but did not meet with the militant group.

Administrators were in contact with Gov. Claude Kirk's office all day Friday, and Kirk himself had stood with police on the edge of the campus just after violence broke out Thursday night.

FAMU Dean B. L. Perry talked to Kirk, and it was decided Kirk would not go on campus.

Gore, Perry and other administrators also maintained rapport with police officials throughout the violence, a university spokesman said today.

In a statement released Saturday, Regents chancellor Mautz said,

"Events of the past two days make it evident that it would be prudent to permit the students at FAMU in this moment of despair and frustration to return to the normalcy of family life.

"I have, therefore, after consultation with the Board of Regents and the Governor, authorized President Gore to close the University for one week."

Gore had been in central Florida when violence first erupted Thursday night, and he immediately chartered a plane to return to campus.

When students were told late Friday that classes would be called off this week, many had trouble finding the money they needed to return home. Gore reportedly made gifts or loans to give a number of students transportation home.

Police and highway patrol troopers shot out city mercury vapor lights which were showing the police positions and blinding the officers.

At one point, the Negroes pushed a car down Palmer Drive at the police barricade, but it veered and crashed through the front of a house across the street from the entrance to the university.

### STUDENTS WOUNDED

Rev. R. N. Gooden said two FAMU students were wounded in the fray, but he did not give the students names and the report is unsubstantiated.

Police periodically fired tear gas into groups of students gathered high on the hill entrance to the campus, but otherwise did not advance past Adams Street onto university property

The National Guard placed on standby, grouped for action at the Armory, but was not called out. The Guard was dismissed by police at the same time highway patrol troopers were recalled at 2:30

Gov. Claude Kirk flew into Tallahassee about midnight to review the situation on the FAMU campus.

He conferred with Police Chief Frank Stoutamire for with Police about 20 minutes at the police station and was joined there by Sheriff W. P. Joyce.

Kirk reportedly visited the scene of the disorder at the Oil Well service station on South Adams Street.

Late in the almost four-hour standoff, arrows rained down on the officers who huddled close to their cars for cover.

### **Riot Charges** Will Be Heard In June Court

TALLAHASSEE-Ten Florida University students, ar-A&M rested recently in connection with riots on the FAMU campus following the assassination fo Dr. Martin Luther King, Jr., were later released on bond, according to authorities.

Three other Negroes are being sought for their alleged involvement in the riots. One is listed as former student William Henry Dupree of Tallahassee, thenry Dupree of Tallahassee, charged with inciting a riot, assault with a deadly weapon and with possession of a fireand with possession of a life-bomb. Davis Charles, missing from the scene, is charged with inciting to riot and assault with a deadly weapon. The third, Al Pridgeon, is charged with in-citing to riot and assault with a deadly weapon citing to riot an a deadly weapon.

The students are scheduled to be arraigned before County Judge James Gwynn on June 12. According to Police Captain According to Police Captain Vester Kelly, the warrants were signed and issued only after a detailed investigation into the riots of April 4 and 5. During the disturbances passing cars were stoned, one mobile home was burned, guns were fired and firebombs tossed.

None of these students was charged with the death of Travis charged with the death of Fravis Crew, III, 19, a white youth who died after a molotov cocktail was thrown into his home. The warrants were issued under the state's new anti-riot law. Kelly praised the administration for complete co-

operation. Among those released on bond are: Thomas Watts, 20, Queens, New York; Eddy (Bo) Bryant, 21, Bartow, Florida; Joseph M. Gibson, 23, Miami, Florida; David Wright, 20, Tampa, Florida; Robert Lampkin, 23, New York; Tony Ervin, 25, Delray Beach, Florida and Clarence Smith, Tallahassee, Florida.

# Over-Stepping Can Trip Reform

Reform movements stumble and fail, mostly, from over stepping; and that could hap pen to one now developing of the Florida A. and M. University campus.

A "Student-Faculty Con mittee on Universit Improvement," rather loose and hastily organized durir the week's suspension classes following rioting on the campus, has come up with four-point resolution that i three-fourths good and on fourth out of bounds.

As Terry Frost, Democrated Education Writer, reports Sunday, unrest on the campinary be due as much to u certainty over the future roand administration of the university as over the broad-social conflicts among Negrou of the nation.

Bluntly put, this institutic which once was operated solly for and by Negroes (and stits, predominantly) is freth about the threat of distitute tegration in the onrush desegregation.

The man on the spot President George W. Gore, Ji who has probably the toughe job in Florida because he mus stand between and act for both his Negro students and faculty and an all-white series of boards and political bodies which control the flow of operating funds and policies.

There is a complaint on the campus that 'the administration' — apparently meaning President Gore—takes too little advice in running the university from the faculty and students.

Hence the resolution adopted Sunday by the committee:

"A. The University must continue to function." OK. That makes the student-faculty position plain to those who would phase it out or merge it with FSU, across town. A legitimate stand.

"B. This functioning must take place in an atmosphere of order with mutual trust and (Continued on Page 2, Col. 5) 16Amiles Declare

confidence between students, faculty and administration."

Fine. That's vital.

"C. The presently constituted faculty-student c o m m i t e e (representatives) will continue to meet every day u n t i l specific recommendations are drafted which we are assured will receive immediate attention by the administration."

Fair enough, assuming the committee really is representative. It suggests "the administration" has indicated willingness to listen. From this point, FAMU might expect to develop about the same sort of rapport between faculty and students which exists at FSU, the University of Florida and other State universities. That's justifiable.

The committee should have stopped there, pending further deliberations and negotiations. But, like a jackleg carpenter, it had to drive the final nall that split the board.

"D. The faculty and students pledge total commitment to m u t u a l recommendations adopted by this committee, and will insist that the administration honor and implement them."

\* \* \* \* \*

Now, if that was only language to show firm intent, it may do little harm; but if the committee and those it is assumed to represent take it seriously as a guiding force,

it is an ultimatum which cannot be accepted by "the administration."

It would mean Florida A, and M. University would be turned over to this particular group of students and faculty to be run as they please—both teaching and discipline.

Student bodies and faculties must understand that they are in no position to "insist" that the administration "honor and implement" their recommendations — not at FAMU, FSU, or any other college, privately or publicly operated.

Students don't have any right even to attend a university, except as they accept policies and regulations of those duly constituted by law and charter to be in charge. No person has a real right to teach at a university, let alone participate in dictating terms to the people who employ him.

If the committee is directing its ultimatum at President Gore, it should recognize that he is properly limited in how far he can go by decisions of the Board of Regents, the Board of Education, the Budget Commission, the Florida Legislature— and the people of Florida who put up the money through taxation.

All of those agencies are part of 'the administration''— and it may be pretty difficult to sell it on the wisdom of Point A ("The University must continue to function") if anyone holds too stubbornly to Point D.

To imply that faculty and students "develop the same rapport . . . which exists at FSU. the University of Florida, and other state universities . . . is a benign insult to FAMU students and faculty and to Negroes in general, As one who has teaching experience at FAMU, FSU, the University of Florida, and has lectured at every other state university, I hardly feel that faculty-student rapport at other state universities is the appropriate paradigm for

If I Declare were informed, it would be aware that the great bulk of student complaints at FAMU are not directed at the faculty. That students have been at odds with administrations at other universities is rather easily and vividly documented. Recently the University of South Florida had its problems with obscenity; Florida State University with narcotics; and the University of Florida with nudity: indicating the dubiousness of FAMU's emulation of them, in student-administration relations.

Duly constituted committees have the right to insist that their recommendations be implemented. There would be no point in making recommendations if commitments to support did not accompany them. Students have the right to insist on anything they like. Faculties have the right to insist on anything they like. Administrations have the right to insist on anything they like. Even editors have this right. If one wishes to interpret the word "insist" to mean "ultimatum" he has the right to do so even though it may indicate a personal problem with semantics.

Students and faculties are among "the people of Florida." Students pay taxes. Faculties pay taxes. By your own reasoning, therefore they have the right to be heard on university administrative matters.
