I have been offered a two-year appointment ^{by} at Michigan State University to serve as a member of its Advisory Team at the University of Nigeria. My specific assignment will be Dean of Students with the responsibility of welding the points of view of the University of London, Michigan State University, and the Inter-University Council of Nigeria, into a workable student personnel program geared to the needs of Nigerians.

May I take this opportunity to express my appreciation to the State of Florida, my colleagues at "FAMU" and above all to you, for allowing me to acquire those experiences that qualify me for an assignment of this type. The University of Nigeria within the past two years has grown from zero to an enrollment of 2,000 students. Plans are to build facilities and a program for 10,000.

I would like to apply for a leave of absence for the period in order to accept the appointment commencing September 1, 1962. At your convenience I would like to discuss our program and the possible adjustments needed.
