ANSWER OF UNIFIED SCHOOL DISTRICT NO. 501 TO PLAINTIFF-INTERVENORS' INTERROGATORY NO. 3

- 3. If your school district is a successor, in whole or in part, to a prior school district or school districts, provide the following information for each such immediate predecessor:
  - a. The name, description or title of each such immediate predecessor school district.

ANSWER: Topeka School District No. 23, Shawnee County, Kansas.

b. Describe the geographical boundaries of each such immediate predecessor school district.

ANSWER: The geographical boundaries of Topeka School District No. 23 are described in part of the Resolution and Petition referred to in answer to Interrogatory No. 2(a). A copy of that description is attached hereto.

c. State the manner in which each immediate predecessor was created and specify the legal authority for its creation.

ANSWER: While Topeka has had public schools since at least 1867, the first known Board of Education consisting of six board

members was apparently created pursuant to 1911 Kansas Session Laws, Ch. 267. According to "Forty Years of History in the Topeka High School, " p. 9 (1910), when "Kansas Territory" was admitted to the Union, Topeka was surveyed as School District Number 23 of Shawnee County. In view of the various legislative enactments since statehood concerning schools in cities of the first and second class, an inability to pinpoint the specific time and manner in which the "immediate predecessor" of Unified School District No. 501 was created exists.

This answer was prepared under the direction and supervision of Wayne Warner, Assistant Superintendent for Business Services, Unified School District No. 501, with the assistance of Kay Oliver, Secretary.
