Dear Rich:

In accordance with our telephone conversation of earlier this date, enclosed please find the original and two copies of the Order extending the time within which Unified School District No. 501 can answer or object to certain interrogatories contained in plaintiffs' second set and respond to the request for production of documents. Without undue burden on you, it would be appreciated if you would approve the order and see that the original is forwarded to the judge's office for his signature.

Also enclosed please find answers to Interrogatory Nos. 1, 3, 6, 10 and 11 of the second set. With respect to Interrogatory Nos. 4 and 5, we will need further clarification before answers can be provided. After reviewing these interrogatories with School District personnel, it appears that it is not clear what information is being sought by these interrogatories. Do these interrogatories relate only to those programs identified in Interrogatory No. 3 regarding CETA, Headstart and Follow Through programs?

In addition, it is not clear whether the term "full time" is intended to mean full time equivalents or to specifically exclude all part time personnel from the information to be provided. Likewise, is the request for "total annual salaries" meant to be a cumulative total for each school or the total amount paid to each teacher for each school during the relevant time period? Do you want information regarding only those administrators who actually are assigned to individual schools or are you interested in information regarding administrators who have duties not relegated to only one school?
