

## American Foreign policy, The Great Deception

The American Political Reality, from its very inception has been, within the context of its Foreign policy, a reality of criminal deception and in consequence, subversion against the peaceful and progressive political and humanitarian aspirations of essentially non-White Humanity.

An appalling foreign policy that has violated the most fundamental Human-Rights of non-White Humanity. A Foreign policy that has enslaved, dehumanized and in consequence, economically and physically impoverished Millions of Members of Black Humanity. A foreign policy that has so insidiously but absolutely subjugated and impoverished non-White humanity for the end of creating a reality of White American affluence which is used to perpetuate the myth of Universal White Racial Supremacy.

The Historical dehumanizations suffered by Third World Humanity was a direct consequence of the philosophical and economic expansionism of the American political reality, yet America's foreign policy within that context, as is today, declares that its function was and is, moral, irrespective of its brutality, its dehumanizations. The American foreign policy within its historical and contemporary contexts alleges that its victim, and what was and continues to be most appalling is that because of its immense economic and intellectual affluence, the American political

reality-its International expansionism and the jurisprudence owning to that expansionism has been perceived as a reality of moralism dedicated to Liberating the non-White Members of Humanity from their alleged Societal inferiority, an allegation deliberately designed by the American political reality so to justify its Criminal Historical Foreign policy and the appalling dehumanizations suffered by Historical non-White Humanity as a consequence.

Within the Contemporary World context, the foreign policy of the American political reality has not changed much from its historical function, which is to say, that the ability of the american political reality to effectuate a deceptive foreign policy has become more qualitative. Contemporary American foreign policy, its economic and political subjugation of an immense part of the Third World, and its subversive intervention in the internal affairs of its Governments and its economic and military contributions to the perpetuation of Third World Capitalist Dictatorial Governments and to totalitarian White Racialist Governments in Afrika, is a foreign policy that wishes to be perceived as a reality of humanism within the context of its allegation that its endeavoring to protect its national interest from what it alleges to be a reality of Communist Philosophical and Economic illegal expansionism. The foreign policy of the American political reality within the contemporary world context has not changed much from what it was historically. It is still subversive of the human rights of non-white humanity as a consequence of its quest to perpetuate the myth of White Racial Supremacy. It is still a most paramount component of the racialist European Doctrine of White manifest destiny, but yet it has managed to get itself per-

ceived as a qualitative reality of moral jurisprudence by colla-

ceived as a qualitative reality of moral jurisprudence by Collaborationist Third World Leaders. Leaders who are paid immensely by the American Central Intelligence agency and Community to condemn progressive foreign policies. Foreign policies of progressive Third World and Socialist European States that have and continue to contribute immensely to humanitarian progression.

Proof of the existence of Such moralistic political reality (for example) manifestly exist within the context of the irrefutable fact that Cuban foreign jurisprudence has never perpetrated against Third World Humanity nor any aspect of humanity, a reality of Colonization, but instead has unconditionally within an economic and military context, contributed to the humanitarian progression of the non-White Human Species irrespective of Race, Creed and National Origin. The Great Cuban Republic is not a Socialist political jurisprudence that has created political and economic spheres of influence by effectuating appalling realities of Violence, of Subversion of fundamental human jurisprudence.

But American Foreign Policy is not exempt. History has manifestly confirmed that american foreign jurisprudence, its atrocities within the context of a qualitative jurisprudence of deception has viciously economically impoverished non-White humanity. American Foreign Policy has and continues to be an atrocious reality of intervention in the internal political affairs of Third World States. The existing pathological political situation within the Third World is exclusively a consequence of a criminal endeavor of american foreign jurisprudence to perpetuate existing spheres of philosophical and economic influence and create new ones in regions where they don't exist.

The root cause of the problems owing to the Third World is a reality of American Central Intelligence Subversion against the progressive political mandate of its brave peoples.

A Mandate calling for the termination of American philosophical and economic illegal intervention.

Inherent within the concept of Third World Revolutionary Internationalism is the Human-Right of Third World Peoples to protect and in consequence defend their territorial imperatives, which is to say, to secure the existence of their respective Continents from American economic and military imperialism-in essence, aggression. It is indeed absurd for the american government to allege that the concept of Third World Revolutionary Internationalism is in essence a reality of illegal expansionism and in consequence Terrorism when it is quite politically and internationally manifest that american foreign jurisprudence has effectuated illegal Military realities through-out the World.

Its base in Cuba, is one of the most concrete manifestations of the illegality of American foreign jurisprudence.

The American Military base in Cuba, when viewed within a historical political context is a political reality of total illegality, a reality of White American Racialist Expansionism.

More evidence of the deceptive and in consequence, dangerous nature of american foreign policy is its total exploitation of the Soviet States illegal intervention in the internal political affairs of Afghanistan, is that Three Third World States economically and politically subjugated by the American Government, have effectuated a tentative agreement to allow the racialist and murderous american government to use military bases in their Countries. What this really means politically, is, that the

american political reality has used the illegal military intervention of the Soviet Union into Afghanistan as a pretext and qualitative means by which to expand its Military existence, its racialist economic and military jurisprudence.

Consequently, its establishment of Military bases in Oman, Somalia and Kenya, is a concrete manifestation of its intensification of its subjugation of the Third World. But this newly evolved political situation is difficult to detect because it is Camouflaged by deception which is an intrinsic function of American Foreign Policy-jurisprudence.

The Third World, within the context of its response to American economic and military expansionism has become a reality of extreme phobia and in consequence, a puppet of the American political reality. The Third World; it refuses to qualitatively recognize the Genocidal Scenario inherent in American Foreign Policy. The Third World refuses to effectuate a Revolutionary analysis of its political and economic problems within a context of a truly humanistic perspective. To do so, would automatically encompass a mandate for a resolute condemnation of American foreign policy and in consequence, the calling forth of a New Concept of Human Progress which would indeed create an extremely adverse situation for the American Corporate State. The Third World has and continues to be brutally victimized by the pathological mentality and greed of European and Euro-American Capitalism, yet it joins racialist America in its-absolutely do nothing attitude-about the International Criminality of Racialist Zionist Isreal. The Third World has

has become a Colony of the American political reality, and if a true process of de-colonization is to begin, it must begin with a resolute, an un-compromising unified Third World Condemnation and in consequence Revolutionary War of Liberation against American Foreign Policy and its inherent scenario to enslave totally the Third World.
