



Dear President Gore:

For some time the Honorable Nathan Mayo has been interested in changing and bringing to date the exhibits of the state which are being shown at the terminal station, in Jackson-ville. It is Mr. Mayo's hope that the Ringling Museum, the University of Florida, The Florida State University and the Florida A. & M. University can be well represented in this exhibit by appropriate dioramas for each. It is Mr. Mayo's purpose to have them placed as the center and feature of the state exhibit.

This matter was discussed with the Board in its November meeting, and the Board directed Mr. Powers to continue with the development of the project.

I have recently received a letter by direction of Mr. Mayo from Mr. Earl W. Brown stating that he estimates the cost of the dioramas to be \$6,000.00. I have discussed this matter with Mr. Rinehart, and he asked that I write to the head of each of our institutions requesting them to contribute \$1,500.00 as a pro rata share of the total cost of the project. Checks should be made out to "Nathan Mayo, Commissioner of Agriculture, for Transfer to the General Inspection Fund - Bureau of Immigration and Advertising".

Mr. Mayo and Mr. Rinehart felt that this will be a very good public relations activity well worth the financial outlay. I assume and I plan to follow through in the matter that Mr. Brown will give the head of each institution an opportunity to confer with him on the arrangement of the dioramas, and an opportunity to approve the final appearance of them.
